3. PSATS opposes House Bill 1620 on wireless broadband collocation Act. PSATS asking for a resolution in support.  
Mr. Grubbs asks Dennis what this is about. Mr. Makel explains that this is similar to the franchise act for cable television. The house bill gives commercial business the right to sell and place antennas for better data communication reception (WIFI). Mr. Makel's recommendation is to adopt resolution to oppose House Bill 1620 which takes away township rights.

Mr. Makel explains the state passed this Act to provide tax relief to active volunteer fire fighters in terms of 100% township property tax relief or by giving volunteers a specific sum of money in terms of township earned income tax relief. Mr. Makel states he has already discussed this with PSATS and some townships are giving \$500-\$750 in earned income tax relief. You give the volunteers the choice of property tax relief or earned income relief. An ordinance will have to be written with the criteria will coming from the Volunteer Fire Department. The Fire Department must also police the criteria. It is determined to place this on the agenda for next meeting to have the ordinance developed with criteria from the Fire Department

**Public Comments:**

Mr. Donohue asks a question regarding the right-of-way appearing on his subdivision and establishing a driveway, he also wants to know if the township is able to install a drainage pipe along the township road and this driveway.

Mr. Donohue ask Mr. Michael, Supervisor in charge of Public Safety, if he can secure an evacuation plan from Key Bank Pavilion. As First Responders, they need to know how to evacuate attendees out of the pavilion, not just into the parking lots. A total evacuation plan is needed from the Pavilion. Mr. Makel states the Township needs to request this in writing. The fire department will meet with Mr. Michael and Live Nation regarding security issues.

Mr. Faux asks Mr. Handick to review the water issue off the road down his driveway.

**Public Announcements:** Radios have been installed in the Road Department vehicles by the Fire Department. They have not been tested for reception out on the township roads yet.


