#### **Chairman's Report:**

Mr. Lemmi announced that the 2012 DCED audit was complete and submitted

## **Public Safety**"

Animal Control: 15 Calls/received at residence, 1 citation, 11 warnings, 1 animal bite, 1 quarantine, 10 hours patrolled, 3 dogs picked up/placed in kennel, 1 dog returned to owner and 11 nuisance calls.

Fire Department: None

Police: 138.35 hours patrolled totaling \$2,192.85 in wages.

- -Income: \$7,317.25 (\$15.60 dog, \$112.63 local ordinance, \$27.22 Title 75 & \$7,161.80 Title 18)
- -Warning to residents that there have been an increased number of break ins so to make sure that all vehicles are locked, outdoor lights are functioning and to report any suspicious activity to 911.
- -There are 26 concerts scheduled to date for the 2013 FNP season.
  - -Training was held over the weekend but there will be a smaller session as some of the initial hires have taken positions elsewhere.

Corporal Rush from the Pennsylvania State Patrol was introduced.

- -In the past two months there have been 2 fatal and 1 near fatal accidents.
- -PSP completed a saturation on April 10<sup>th</sup> in order to try to enforce speed limits.
  - -36 citations and 20 warnings were issued.
- -In March, PSP responded to 46 incidents, 1 burglary and several minor crashes.
  - -Corp. Rush was thanked by the Board of Supervisors.
- -Mr. Donohue asked if a certain area was being targeted in the break ins.
  - -Corp. Rush explained the prophecy system they use to determine that and said he could get back with an answer but it takes time to map it out.
  - -Officer Henry stated he has responded to 2 in the Aunt Clara Road area.

-Mr. Duerr explained that even telephone wiring is being stolen.

-Corp. Rush stated that Verizon was offering a \$50,000 reward for stolen wire.

## **Road Report:**

Total Wages \$14,544.68 with a total of 753 hours (78 shop, 624 road, 16 personal, 11 OT and 24 holiday)

# **Approve Expenses:**

- -Mr. Lemmi made the addition of Animal Control in the amount of \$300 that was omitted.
- -There was a question regarding the invoice for Traffic Systems and Services.
  - -Mr. Duerr explained that there are 3 transformers in that area and some houses have experienced damage at the same time the equipment was damaged.
  - -Some of the ground wiring has been adjusted so hopefully that will prevent surges.

#### **New Business:**

1. Approve Police Union Contract

Mr. Duerr explained that the contract called for a 5% wage increase effective January 1, 2013 and a 2.5% increase for each additional year ending in 2016.

-There have been no major changes to the contract.

# 2. Dumpster Quotes

The Township received two quotes for dumpster quotes for the 2013 Clean Up Days

NC Sanitation: 30 yard roll offs \$325 up to 5 tons; \$37 each additional ton

-10% fuel surcharge

-Scrap Box \$100 per pull with scrap yard prices to be credited to account

Big's: 30 yard roll off \$425 up to 6 tons; \$31 per each additional ton

-Scrap metal boxes \$275 per pull

There was discussion regarding the additional tonnage price and the fuel surcharge and it was determined that NC Sanitation would still come in less that Big's.

- -Mrs. Lemmi had asked for \$1 increase per hour.
- -Mr. Duerr proposed .45 per hour for Dee Bailey and .50 per hour for Howard Webb as he is still making minimum wage.
- -Mr. Niederriter asked what was being done with the Act 13 funds and if they could be used.

# Motion: To rehire Dee Bailey at an hourly rate of \$9.65 and Howard Webb at an hourly rate of \$7.75 for the 2013 park season.

- -Mr. Grubbs explained that the DEP mandates that if a sewage system malfunctions, they must connect.
- -Mr. Donohue asked if these were from Phase 1 and how many residents were not hooked up.
  - -Mrs. Voelker stated she was not sure but estimated it was between 15-20.
- -Mr. Grubbs stated that submitting the forms required approval because it may involve an expense if the system is not malfunctioning.
  - -Mrs. Voelker stated that it was her understanding that the Sewer Authority would be invoiced.
- -Mr. Riter asked why only 3 residents who have not connected were being turned in.
  - -Mr. Grubbs said that the Sewer Authority had to begin somewhere.
  - -Mrs. Voelker stated that this one step to force people to hook up to Phase 1. She stated that they are putting liens on properties and will ask that water service be disconnected.

Motion: To authorize the Washington County Sewage Council to enforce sewage complaints from the Hanover Township Sewer Authority in Phase 1 only.
